# **CAPPED MIGRATION UPDATE (2)**

As many of you will know, the 2011/2012 limits for Tier 1 and Tier 2 visas have now been published and you can view the UK BA's initial announcement here:

### Tier 1

Tier 1 (General) will be closed. No information is currently available on how existing Tier 1 (General) visa holders will be affected. The Entrepreneur and Investor strands will be reformed but not capped, while 1,000 visas will be available under a new "exceptional talent" route for those with "international recognition in scientific and cultural fields". The Tier 1 Post Study Work strand will be reviewed separately.

### Tier 2

Tier 2 (General) visas will be capped at 20,700 for 1 April 2011 – 31 March 2012, or 1,725 per month. Sponsors will need to apply for Certificates of Sponsorship and a ranking system will be used in oversubscribed months. The limit will not apply to in-country applicants, Tier 2 dependants or Tier 2 (General) roles where the salary is more than £150,000 pa.

Intra Company Transfers will also be excluded from the cap. Established Staff (those with overseas service of at least 12 months) can obtain leave for up to 5 years if their annual salary exceeds £40,000, or up to a 12 month visa if earning between £24,000 – £40,000 pa. The existing rules for the Graduate Trainee and the Skills Transfer sub-categories of the ICT route will continue to apply.
